

PETITION FOR PERMISSION TO COHABIT AS BROTHER AND SISTER

This petition may be used **only if** (1) validation is impossible; (2) separation is extremely difficult; (3) there is no danger of scandal; and (4) danger of incontinence is precluded by the advanced age of the parties, serious illness, impotence, or some similar factor. Each petition should be accompanied by a letter from the priest commenting on the above points and presenting arguments in favor of and/or against granting the permission.

Most Reverend Bishop,

We, the undersigned, realizing that our marriage is invalid in the sight of God and that we have no marriage rights whatsoever, but finding it extremely difficult to separate, humbly request permission to live together as brother and sister, such that the mere fact of our cohabitation would not give rise to the presumption that we are obstinately persevering in manifest grave sin, thereby allowing us to be admitted to Holy Communion, with due regard for the norm of law, the good of the Church, and the reverence owed to that Most Holy Sacrament.

PROMISES *(to be made separately by each party in the presence of the other party and witnessed by the priest)*

Realizing the sacredness of an oath, the gravity of the crime of perjury, and my obligation before God in this matter, I solemnly swear:

1. That under no circumstance will I ever attempt the conjugal act or other acts in violation of perfect continence with my present partner.  
*(numbers 2-4 are omitted for non-Catholics, unless they are considering becoming Catholic)*
2. That if I violate this promise I will not approach Holy Communion until I have been absolved through sacramental confession; and I further understand that, depending on the circumstances, the confessor may judge that I cannot be absolved until I have separated from my present partner.
3. That I will receive Communion only in churches where my marital status is not known among parishioners.
4. That I will explain my status to my pastor, spiritual advisor, or confessor, and will report to him at least once a year on the observance of my promise.
5. That I will treat this matter confidentially and otherwise exercise caution to avoid causing scandal by the use of this permission.

So help me God and these Holy Gospels, on which I place my hand.
